National Hit-and-Run AWARENESS MONTH

Michael Pike, Managing Partner at Pike & Lustig, joined The Florida Highway Safety and Motor Vehicles' "Stay at the Scene" Campaign to spread awareness of hit-and-run protocol in honor of February being National Hit-and-Run Awareness Month. The goal of the campaign was to educate drivers on what to do if they're involved in a crash, the penalties for not staying at the scene and how to report tips to police.

In Florida, leaving the scene of a crash where there are injuries or fatalities is a felony. If the crash results in injuries, the individual may have their license revoked for at least three years, serve up to five years in prison, and have to pay a \$5,000 fine. If the crash involves fatalities, the person who fled faces a mandatory minimum prison sentence of four years in addition to a \$10,000 fine and their license revoked for three years. Pike discussed the following steps to follow if and when you are in an accident:

1. Check to make sure you are okay and remain calm;
2. If possible, move to the side of the road. Remove your keys if you get out of your vehicle and stand in a safe place;
3. Check on anyone else involved. Call 911 if anyone might be injured or a vehicle is inoperable;
4. If there are no injuries or major property damage, gather information. Get the name, driver license, insurance, and tag information from the other driver(s). Preserve evidence. Take photos of the vehicles and information if you can't write it down and then file a report online;
5. Call an attorney immediately and inform them of the situation; and
6. Most importantly, always stay at the scene. Leaving the scene of a crash will only make matters worse. Staying at the scene will not only spare the driver significant legal penalties, but may also save a life.

Daniel Lustig Serves on Anti-Defamation League Panel Discussing Hate Crimes in the Spanish Speaking Community

Daniel Lustig, partner at Pike & Lustig, was featured along with other leaders from the Hispanic community in an event discussing hate crimes being on the rise. PIKE & LUSTIG WINS IN APPELLATE COURT: Circuit Court Judge's Ruling Reversed



In the case of Thomas G. Hinners, Mary J. Wamser and Florida Affordable Housing, Inc. (Appellants) v. Brian J. Hinners (Appellee) in Florida's District Court of Appeal's 4th District, Pike & Lustig Partners Michael Pike and Daniel Lustig represented the Appellants in their request to reverse the judge's ruling on their case in circuit court, see [Hinners, Wamser and Florida Affordable Housing, Inc. v. Hinners No. 4D20-1320 \(2021\).](#)

Pike & Lustig argued that nonfinal orders denying their motion for prejudgment writ of replevin and granting temporary injunction of Appellee Brian Hinners should be reversed and the temporary injunction should not have been entered. Citing precedent, attorneys Pike & Lustig argued that the Appellants deserved possession of the checkbook and check card for the Florida Affordable Housing, Inc. (FAHI) company that the Hinners had founded together. After a thoroughly hard-fought case, the judge sided with the Appellants. Pike & Lustig proved that the trial court erred in entering the temporary injunction and denied the Appellants' prejudgment of writ of replevin. The court reversed in part and remanded for the trial court to dissolve the temporary injunction and issued a prejudgment writ of replevin successfully granting possession of those financial entities to the Appellants.

BIKE SAFETY MONTH

March is Florida Bike Month and to educate the South Florida community about bicycle safety, Pike & Lustig joined with Palm Beach County Vice Mayor Robert S. Weinroth to host a Bicycle Safety Webinar. The virtual presentation also featured Sergeant Hannes Schoeferle, Delray Beach Police Department; Alyssa Frank, Palm Beach Transportation Planning Agency; Kristy Breslaw, Boca Raton Triathletes President and Avid Cyclist; and Maria Price, Bicycle Crash / Hit & Run Survivor.

Though bicyclists and pedestrians represent just 2% of commuters in Palm Beach County, they made up a whopping 30% of all transportation-related fatalities on county roadways from 2018-2020, according to the Palm Beach TPA. The uptick in the number of accidents involving pedestrians and bicyclists may be attributed to the surge in health and fitness during the pandemic. Regardless of causation, Pike & Lustig used this webinar as an opportunity to call on local leaders to take a more proactive approach aimed at preventing accidents.

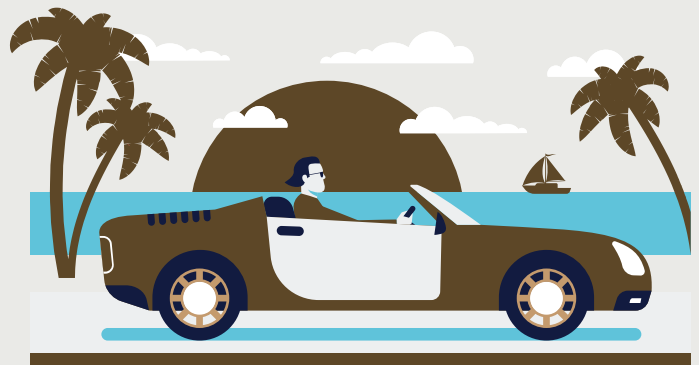

BIKE SAFETY MONTH



Safety Tips for Bicyclists:

- Wear protective gear like a properly fitting helmet, fitted clothing, and shoes with a good grip
- Check your bicycle for any malfunctions before riding
- Make sure you are always visible with bright colors during the day and lights at night
- Be aware of dangerous road conditions
- Obey all traffic laws
- Ride with the flow, on the right-hand side of traffic
- Yield to traffic when appropriate
- Signal your intent and be predictable
- Do not ride distractedly; stay alert and focused
- Look twice before turning or crossing an intersection
- Be careful around parked cars



Safety Tips for Drivers:

- Stay aware and actively look for cyclists
- Know that cyclists have the same rights on the roads as you do
- Be patient around cyclists even if they are moving slower than traffic
- Be predictable and communicate your intentions with cyclists
- Do not pass a cyclist until you are sure that your passing lane is clear
- Look out for cyclists when turning and at intersections
- Give cyclists plenty of space; never tailgate
- After parking near a bicycle lane, watch for cyclists before you open your door
- Always yield the right of way to a cyclist
